## Bridal Makeup Contract

*All prices include the option of false lashes*

Makeup Consultation & Trial -  
**\$90** Wedding Day Makeup For The Bride  
(Includes Touch Up Kit) - **\$140** Makeup  
Application For Bridal Party / Attendant -  
**\$120/ person** Partial Makeup  
Application - **\$65**

[There is a **minimum** of 4 people  
required to book Bridal Makeup Services]

**Prices do not include gratuity**

**Deposit:** To secure a date and scheduled  
makeup time, a signed contract and a  
deposit of \$65 is required. This deposit is  
non-refundable and will be applied  
towards the \$130 balance due for the  
Bride's Wedding Day Makeup Application.

**Payment:** The final balance is due on the  
day of the event – no exceptions. **Cash  
only.**

**Liability:** All brushes and makeup  
products are kept sanitary at all times.  
Any skin conditions or allergies are to be  
reported by the client to the Makeup  
Artist prior to application.

**Travel:** A fee of \$75 / each hour traveled  
will be applied to on location services.  
(Additional fees for tolls/bridges may  
apply)

**Location:** Is up to the discretion of the  
client. A set-up table / work area needs to  
be made available for the Makeup Artist  
at said location.

**Cancellation Policy:** Cancellations must  
be made 40 days prior to your reserved  
date or you will be responsible for the full  
amount of services agreed upon in this  
contract. Bookings without a final number  
of services determined will be  
responsible for the minimum amount.  
(Bride + 3 people = \$460)

**Photography:** Client agrees to full use of  
photographs taken during or after  
services provided for portfolio and  
promotional use.

**Service:** Makeup Artist will perform  
services at said location and time. Makeup  
will be completed to client's satisfaction  
within the allotted makeup application  
time.

**Timing:** Start and stop time of services is  
to be determined by the client, while  
considering the following: **Each Makeup  
Application requires 35-40 minutes to  
be completed. A Makeup Application  
for a Bride requires 45 min to 1 hour  
to be completed.**
